Has obtained **EC TYPE EXAMINATION INSPECTION CERTIFICATION**, in compliance with what is stated in *Directive 89/686/EEC* and in agreement with the applicable test procedures according to standards *EN ISO 13688:2013* general requirements and *EN ISO 20471:2013* designated PPE CLASS 1 of high risk of low visibility, having attained the levels of provision specified in **TEST TECHNICAL REPORT Nº2016EP3152CE** and in **PPE's TECHNICAL DOCUMENTATION**.

Said certification is valid for the following articles:

**PPE TYPE “PANTALÓN HV MODELO NAOS (9300)”** destined to indicate the user's presence in both daytime and at night in hazardous situations with low visibility.

**PPE DESCRIPTION:**

A garment covering the wearer from the waist to the feet and made in fluorescent yellow and navy blue woven fabric with silver grey bands. The garment comprises front and rear components and a waistband. The two front components, left and right, are joined to the back at the inside and outside-leg seams and to each other at the crotch and fly which fastens with a zip covered with an internal and external flap. The zip is made in black plastic with a metal pull. Each front leg has a French pocket at the hip and two darts. At the thigh, each side over the outside-leg seam is a patch pocket with a flap fastened with two tabs of self-fastening tape. Each front component has two silver-grey reflective bands affixed by stitching and separated by 16 cm: the space between the bands is made in fluorescent yellow fabric. Below the lower band to the trouser bottoms is navy blue woven fabric. Above the upper band is a section of navy blue webbing, and there is an identical section below the lower band. The waistband at the back has an interior elasticated section, gathering the trousers to the waistband. The trousers button in line with the fly with a navy blue acetate button and buttonhole. Distributed evenly around the waistband are five belt loops: one at the front each side, one at the back each side and one in the small of the back over the seat seam. The back trouser legs have the same distribution of colours and bands as the front. At the seat each side is an expanding patch pocket fastened with a tab of self-fastening tape. The trouser bottoms end in an interior backstitched hem.

The materials that form the PPE, are described in the test technical report n° 2016EP3152CE.
